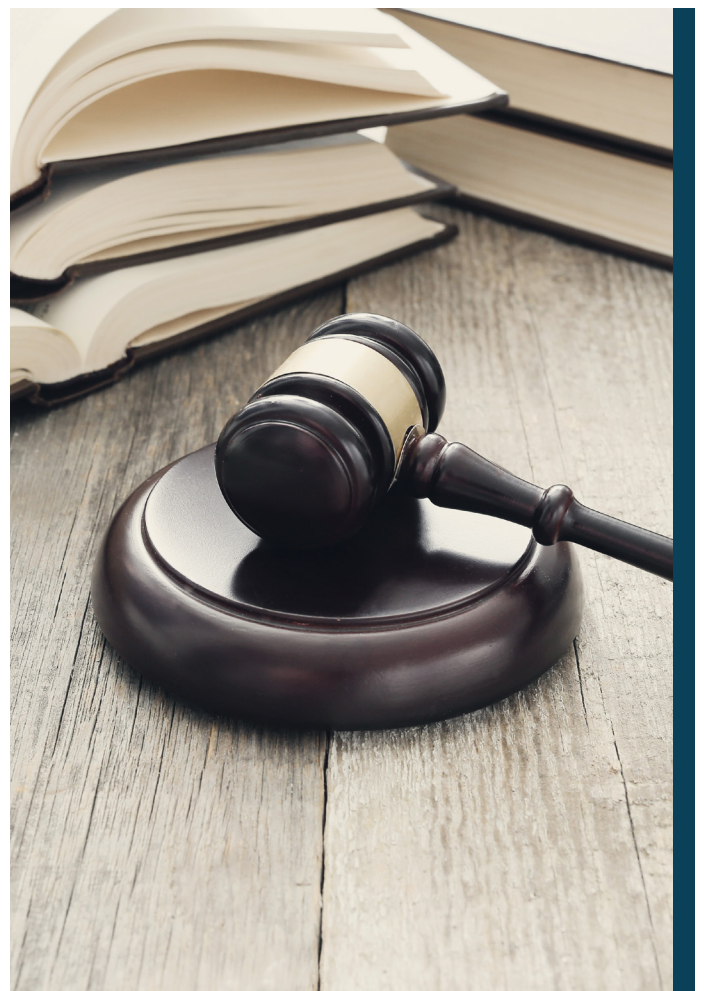
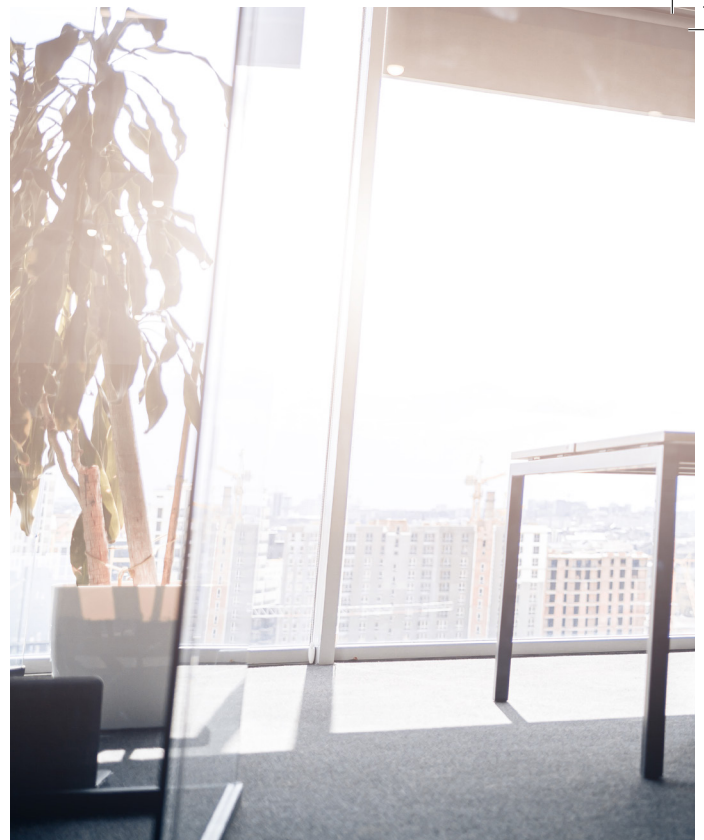

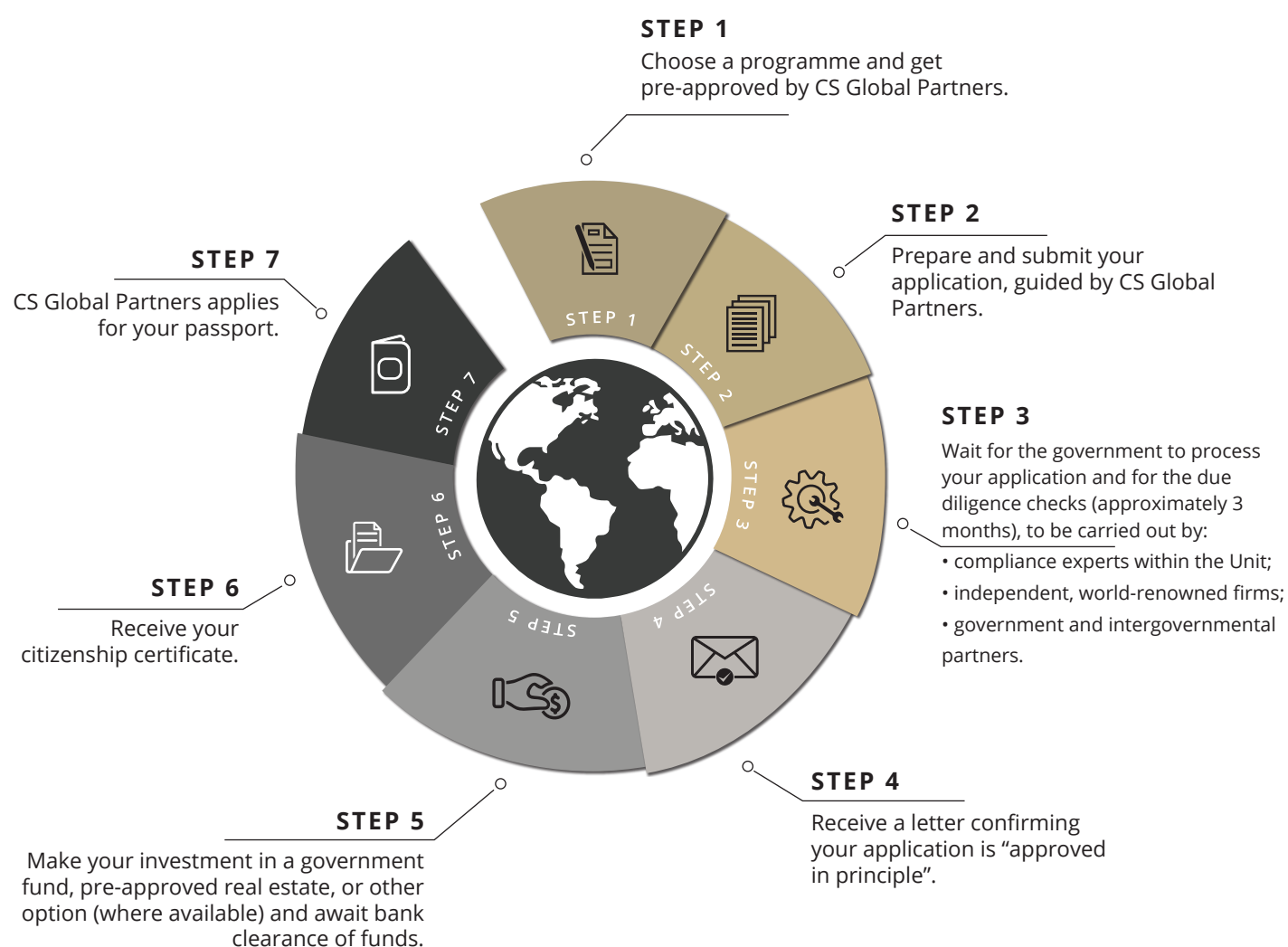

Application Lifecycle and our involvement throughout the process:



Once we formally start the onboarding process, a three-member team will manage your client's application:

Antigua and Barbuda

Antigua and Barbuda offers four routes to citizenship, including the non-profit National Development Fund and an investment in real estate.



Saint Lucia

Saint Lucia offers citizenship through, a donation to the National Economic Fund, investment in a Real Estate Project or investment in National Action Government Bonds



Dominica

Dominica provide a popular programme offering two routes to citizenship, including the Economic Diversification Fund and an investment in real estate.



St Kitts and Nevis

St Kitts and Nevis are the pioneer of the global investor immigration industry, offering four routes to citizenship, including the Sustainable Island State Contribution and an investment in real estate.



Grenada

Grenada offers two routes to citizenship, including the National Transformation Fund and an investment in real estate.



Türkiye

Türkiye provides a popular programme among Middle Eastern applicants, offering five routes to citizenship, including Government Bonds and an investment in real estate.



Malta

Malta grants citizenship for exceptional services, suitable for high net-worth individuals who are interested in relocating to Malta.



Egypt

Egypt recently launched their citizenship programme in 2020 offering four routes to citizenship, including investments in projects and real estate.



Austria

Austria grants citizenship for exceptional achievements, suitable for high net-worth individuals who are interested in relocating to Austria.

Residency by Investment Programmes



Canada

The Canada Start-Up Visa Program allows approved investors to obtain permanent residence status in Canada while building certain businesses in Canada and creating jobs for Canadians.



Greece

Under the Greece Golden Visa Programme, non-EU/EFTA foreign nationals can obtain a residence permit with a real estate investment.



Italy

Italy's Investor Visa enables non-EU foreign applicants to receive Italian residence in return for a qualifying investment.



United Kingdom

The UK offers residency options to foreign skilled nationals and entrepreneurs who meet the application requirements*



Monaco

Non-EU/EFTA foreign nationals who make a qualifying investment in the country are eligible to apply for a residence permit.



Malta

Non-EU/EFTA foreign nationals who make a qualifying investment in the country are eligible to apply for a permanent residence permit and citizenship thereafter.



Cyprus

Non-EU/EFTA foreign nationals may apply for a permanent residence permit in Cyprus through various investment options.



Portugal

The Portugal Golden Residence Permit Programme provides the right to live, work, and study in Portugal to non-EU/EFTA foreign investors.



Singapore

Singapore grants permanent residence status to eligible investors who drive growth in the country's economy.



Spain

Non-EU/EFTA foreign nationals who make a qualifying investment in the country are eligible to apply for the Golden Visa Programme.



Switzerland

Non-EU/EFTA foreign nationals who are not gainfully employed in Switzerland can obtain a Swiss residence permit if they agree to pay a minimum net annual tax.



United Arab Emirates

The UAE Golden visa is a long-term residence visa which enables foreign talents to live, work or study in the UAE while enjoying exclusive benefits.



United States of America

The USA EB-5 Immigrant Investor Program offers foreign investors a pathway to US permanent residency and citizenship, provided they invest significant capital and create jobs in the US.
